Annual indexing occurs on April 1st, in accordance with Statistics Canada Quarterly, Building Construction Price Index.

By-law 48-21 applies to lands in the geographic area of the Region identified as Recovery DC Area on Schedule "A" where such lands require a servicing allocation under a Future Allocation Program.



## Region Residential Front-Ending Recovery Payment Information

The Front-Ending Recovery Payment has a water, wastewater and roads component that will apply to all Regional Urban residential development and Rural development connected to water and/or wastewater services. For Rural development not connected to water or wastewater services, only the roads portion of the Front-ending Recovery Payment will apply.
