

**Candidate's Declaration of Name to be Used on the Ballot****Summary:**

In accordance with the powers afforded to the Town Clerk & Returning Officer in Subjection 12 (1) and subject to Subjection 41 (2), of the *Municipal Elections Act, 1996*, the following procedures shall be referenced when determining how a candidate name will appear on a municipal election ballot.

- (1) The name by which the candidate is known as in the general public shall be the name to appear on the ballot. General public is interpreted to mean "relating to, or affecting, a nation, state, or community".
- (2) It is the discretion of the candidate whether they wish to include a middle initial(s) on the ballot, except in the instance where two names are identical or similar enough that in the opinion of the Town Clerk & Returning Officer they should be distinguished by including a middle initial(s) to avoid confusion. Should two candidates have the same first name(s), middle initial(s) and last name(s), the candidates' qualifying addresses shall also be included on the ballot.
- (3) Where the candidate has filed his or her Nomination Paper using a name which is not the name by which he or she is known by in the general public, and for which he or she is unable to produce identification acceptable to the Town Clerk & Returning Officer, the candidate may be required to take a declaration which states that he or she is known by that name in the general public.
- (4) The Town Clerk & Returning Officer may not allow a name(s) to be shown on a ballot because of, but not limited to, an offensive or derogatory meaning or implication.
- (5) No reference to a candidate's occupation, degree, title, honour or decoration shall appear on the ballot.

**Instructions to the Candidate**

**Candidates must complete Parts I and II**

- A *Declaration of Name to be Used on the Ballot* may only be filed in person or by an agent; it may not be faxed, mailed or e-mailed. Submit this form in person to:

- If this declaration is being submitted by an Agent:
  - the form must be commissioned by a Commissioner of Oaths;
  - the Agent must show his/her identification in addition to a copy of the candidates identification
