Nomination Process

- Tuesday, May 1, 2018 to Friday, July 27, 2018 at 2 pm.
- Must be filed in person by the candidate or by their agent.
 - They cannot be mailed, emailed or faxed.
- Must be an original of your identification
 - two pieces of identification
 - showing your name, qualifying address and signature

Nomination Process

- Filing fee:
 - \$200 for Mayor candidates
 - \$100 for Trustee, Regional and Town Councillors
- Accepted Payment
 - cash, certified cheque, money order or debit card

Nomination Process

- Book an appointment
 - Monday to Friday, 8:30 am to 3:00 pm
- Appointments are 30 minutes
- No appointment?
 - May need to wait if another nomination appointment is underway

- **Town Clerk's office has moved:**

- Nominations will be accepted at the Community Services counter in the main lobby of Town Hall.

Election Signs



- Election sign application
- Be registered as a candidate or third party with the Town of Milton
- Pay the election sign fee of:
 - \$300 for Mayor, Regional Chair, Provincial and Federal candidates or some third parties
 - \$150 for all other offices including school trustee candidates or some third parties
- Election Sign fees refundable
 - Not third party

Election Signs

- 45 days prior to voting day
 - September 7
- 72 Hours to remove election signs
 - October 25



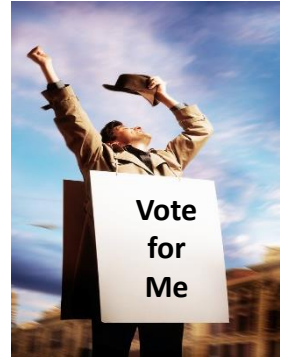
Election Signs

- Enforcement
 - Removed without warning to candidate
 - Candidate not informed after removal
 - Signs destroyed
 - No compensation
 - Candidate cannot retrieve
 - Fines
 - \$79 per sign
 - \$300 per sign - Clerk's desecration



Election Signs

- **Restrictions** (Not billboard or signs on vehicles)
 - Illuminated
 - 32 square feet
 - + 7 feet
 - Interfere with the safe movement of pedestrians or vehicles



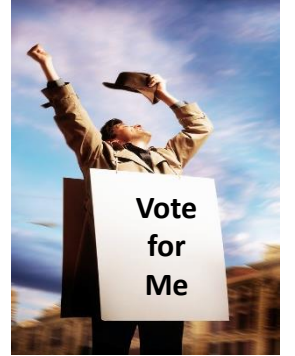
Election Signs

- Sign Location
 - Not allowed on:
 - Regional road Right of Way
 - Local roads
 - Public Property
 - Parks
 - Ward running in
 - Urban area
 - Within 10 metres of same candidate sign
 - Non-Urban area
 - Within 50 metres of same candidate sign



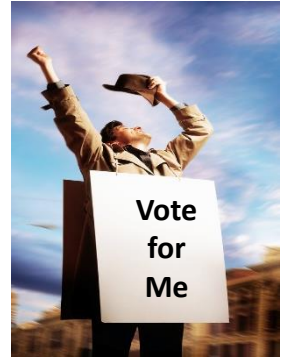
Election Signs

- Sign Location
 - Allowed on:
 - Minor arterial roads
 - Multi-purpose arterial roads
 - Collector roads
 - Private Property



Election Signs

- Boulevard in front of residence
 - Detached or semi-detached
 - Owners permission
 - Front Lawn
 - Owners permission



Election Signs

- Voting Location
 - Not permitted
 - Entire property including road allowance
- Town logo / wordmark
 - Not to be used

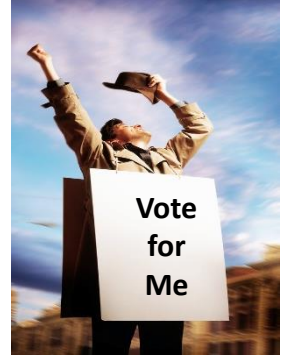


Election Signs

- Candidates responsibility
 - Own signs
 - By-law requirements are met
- No appeal process
 - Property tax bill or
 - Collections / Court
